These cookies are set directly by Koseapp. They are primarily used to provide core functionality, remember your preferences, and help personalize your experience.

Third-Party Cookies:

These cookies are set by trusted third parties (such as analytics providers and advertising networks) on our behalf. They help us analyze usage patterns and deliver targeted advertising. For example, if you visit our Sites after looking at real estate content, you might later see ads for home furnishings or related services on third-party sites.

Session Cookies vs. Persistent Cookies:

Session Cookies are temporary and expire once you close your browser.

Persistent Cookies remain on your device for a set period or until you manually delete them.
